PPRAG 1338 Pharmacy Based Screenings (1.5qhrs)

Instructor: Dr. D. Otis

Description: Through active participation in lecture discussions as well as laboratory exercises, the student will be prepared to

develop health-screening programs in a variety of pharmacy practice settings. The focus is risk factor assessment and hands-on experience with technological devices related to cancer, cardiovascular disease (blood pressure and cholesterol), diabetes, and osteoporosis. This course will address OSHA training, CLIA regulations, policies and procedures, and implementation of screening programs. The course meets once weekly for either lecture or a lab/workshop. The course evaluation is based upon competency assessment of techniques during the lab/workshop,

two group projects, and a final quiz.

**Pre-requisite:** PHIDG 1605 Integrated Sequence 5.

PPRAG 1433: Introduction to Specialty Pharmacy (1.5ghrs)

Instructor: Dr. Janelle Vircks

Description: This elective provides an opportunity for students to learn current therapies, management of patients and other

operations requirements within specialties including Solid Organ Transplant/BMT, Oncology, Inflammatory

(Rheumatology, Dermatology), and Infectious Disease (HIV and Hepatitis C). The course is composed of alternating

disease state overview presentations with student case study presentations the following week for practical

application. A take home quiz designed in part by the student presenting will be completed by rest of class utilizing

guidelines, class material and any references needed.

**Pre-requisite:** Enrollees must be in PS-2 year.

PPRAG 1442 Advanced Geriatric Pharmacotherapy (1.5ghrs)

Course Director: Dr. Nicole Early

Description: This course is designed to enhance students' knowledge and skills related to geriatric pharmacotherapy. The course

will provide an introduction to general principles of aging, roles of pharmacists in working with geriatric patients, and an overview of geriatric syndromes. The format of the course will involve brief lectures, and students will be expected to actively participate in discussions and case-based assignments. There will be an emphasis on managing the

health care needs of patients with multiple comorbidities.

Prerequisite: Concurrent enrollment in or completion of PHIDG 1606 / PHIDG 1607

PPRAG 1411 Pharmacological Management of Chronic Pain (1.5qhrs)

Instructor: Dr. Robert Kronenberg

Description: The objective of this course is to provide students with a basic understanding of the differences between chronic and

acute pain. Pharmacological treatment of acute pain is relatively straightforward; management of chronic pain is often complicated and rarely achieves the patient quality of life goals. Upon completion of this course students will understand how to assess pain; understand the differences between addiction, dependence and tolerance; be able to recommend appropriate medication therapies for nociceptive and neuropathic pain; understand the reasons for the multitude of available analgesic choices; understand the role of complementary and alternative medicine (CAM); and

be conversant with the legal and ethical issues of pain management.

**Prerequisite:** PS-2 status, concurrent enrollment in PHIDG 1607.

PSCIG 1357: Introduction to Forensic Science for Healthcare Professionals (1.5qhrs) Max: None

Instructor: Dr. Oliver Grundmann

Description: The use of forensic toxicology in the battle against the increased abuse of licit and illicit drugs is an important field of

study. This course will introduce the main areas of forensic sciences and especially the involvement of physicians,

pharmacists, and nurses in discovering and preventing the abuse of drugs.

Prerequisite: PPRAG 1524 Pharmacy Law and Public Policy

IPECG 1401C Improving Patient Safety 1 (1.5qhrs)

Course Directors: Dr. Cara Copeland (CDMA), Dr. Larry Sands (AZCOM); Dr. Shawn Tennant (CPG)

Description: This interprofessional on-line course will introduce students to how they can improve patient safety and reduce

medical errors. The course instruction is through on-line Institute for Healthcare Improvement (IHI) educational modules, reinforcing that knowledge through authentic-team case study discussions and self-reflection writings.

Completion of IPECG 1401 and IPECG 1402 will lead to an IHI certificate.

PPRAG 1301 (1.5 credits) or PPRAG 1302 (3qhrs): Special Project/Research PSCIG 1301 (1.5 credits)\* or PSCIG 1302 (3qhrs): Special Project/Research

Instructor: Faculty Sponsor

Time: Varies

Description: This research-based course provides an opportunity for students to work with individual faculty mentors on research

projects of variable scope. All research projects require approval by the appropriate Department Chair and the Dean's Office. A completed and signed Special Project Request Form is required. The Special Project Form must be completed, signed by all parties and turned into the Associate Dean, College of Pharmacy prior to November

21st in order to register for this elective.
